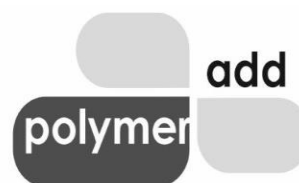

7. Handling and Storage

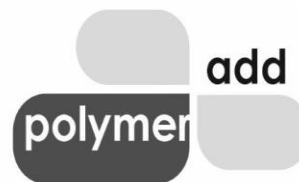

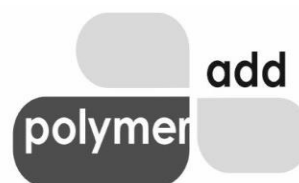

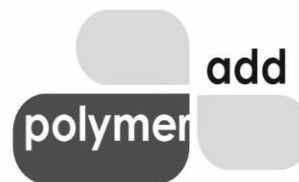
